ALL corresponding authors of accepted abstracts must prepare an IEEE Xplore compliant version of their final papers using the IEEE PDF eXpress system.

BEFORE CREATING A PDF

Add the copyright notice to the bottom of the first page of your source document. If necessary, contact **Samantha Tola** at stola@pcm411.com for the appropriate copyright notice.

Proofread your source document thoroughly to confirm that it will require no revision.

PDF CONVERSION

Authors must use the IEEE PDF eXpress service to prepare and/or validate their camera ready abstract. IEEE PDF eXpress will be needed to either (a) convert an MS Word document into an IEEE Xplore compliant PDF format or (b) check a previously-created PDF file to ensure that it is IEEE Xplore compliant. In either case, IEEE PDF eXpress will create the document that will be uploaded to the IVEC final abstract submission site.
